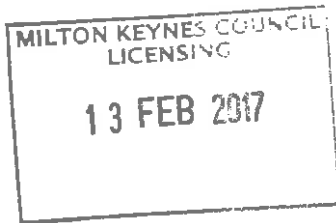

**Ref: Variation to Premise Licence, MRH Viking, Viking Service Station, 10-14 Aylesbury Street, Bletchley, MK2 2BA**

To the Licensing Team,

We object to the Variation to Premise Licence to extend the timings for alcohol supply to 24 hours a day.

We live in the immediate vicinity of the property with our two young children (our house is directly opposite the premises) and object on the grounds of antisocial behaviour (crime and disorder, public safety, public nuisance).

We have lived in the property for 5 years and over the course of that period have experienced a lot of antisocial behaviour and noise on the road directly outside at night time. The antisocial behaviour is almost always caused by those under the influence of alcohol. As the service station is open 24 hours a day it is a stop-off point and groups do congregate outside at all hours of the morning, particularly on Friday and Saturday nights and we are woken by the noise. We are concerned that this behaviour will increase if the licence is extended to serve alcohol 24 hours a day. It is not necessary, will encourage people to carry on drinking on the streets and is undesirable in a residential area. Not only will it increase the likelihood of antisocial behaviour, but the amount of people visiting the service station during the night is likely to increase, which will have a direct impact on us as residents.
