**Woburn Sands Town Council object to this application for the following reasons.**

1. This premise has never applied for any food take-away license.
2. This premise has never applied for a license to be open in the evenings.
3. The location has residential flats above the shops in the High Street the noise associated with take –away with cars pulling up and doors closing and driving away would be detrimental to residents and unacceptable.
4. Take Away also creates a litter problem, and the footpath on this part of the High Street is very narrow with no room for a litter bin.
5. Other premises that have permission for a take-away do not operate after 23.00 on any evening.
6. The Summerlin Centre license conditions were to close at 23.00 due to being in a residential area with people leaving and driving away etc. and the same should apply to this application.
7. The aromas created by this premise would also be unacceptable to residents at such a late hour. The Flue is on the low roof.
8. There could also be noise from people coming out of the local pubs and using this take away service as most times people are a little louder than normal when been drinking.
9. The use of the premises as a hot food take-away is not ideal as there is no easy drop off parking location.
