1. Recommendations

- 1.1 That the Council tax base for 2010/11 be set at 81,759.38 Band D equivalent properties
- 1.2 That the provision for uncollectable amounts of Council Tax for 2010/11 is reduced to 1.15%, producing an expected collection rate of 98.85%.

2. Issues and Choices

- 2.1 This report is a component of setting the Council Tax for the forthcoming financial year. The monies available for service delivery in this year depend on the amount of Council Tax that we believe will be collected and we have to be careful to estimate this accurately.
- 2.2 As the report outlines, the performance of the council tax collection service continues to improve, both in the money we are collecting for the current year and in our recovery of arrears.
- 2.3 The setting of a realistic and prudent collection rate for Council Tax in 2010/11 is an essential component of the overall budget strategy. If the collection rate set is over-optimistic, this may result in a deficit on the collection fund at the end of 2010/11, the major part of which would need to be met from Milton Keynes 2011/12 Budget. This would impact adversely on the overall budget strategy.
- 2.4 The proposed tax base of 81,759.38 Band D equivalents would result in Council Tax income of £89.5m for Milton Keynes' element if there is no increase in the Council Tax in 2010/11. The overall resources for the 2010/11 budget will be dependent on the outcome of the final formula grant settlement due to be announced around the end of January 2010, although it is not anticipated that there will be any changes from the provisional settlement figures published in December 2009.
- 2.5 The Local Government Act 2003 amended the Local Government Finance Act 1992, and from 2004/05 a full Council meeting is no longer required to adopt the Council tax base that is used when setting council taxes. It was

approved at full Council on 13th January 2004 that the Cabinet would set the tax base for the 2005/06 financial year onwards.

- 2.6 The tax base calculation is set out at Annex F1 and must be approved by the 31st January 2010. Annexes F2 and F3 attached analyse the figures at Parish level in terms of Band D equivalents and numbers of properties respectively.
- 2.7 The tax base calculation is based on the number of properties at 14th September 2009 and the discounts applicable on 5th October 2009. These are then increased for estimated new builds within the 2009/10 and 2010/11 financial years. Finally, there are then two further adjustments, a deduction for estimated non-collection and an increase for the effect of discounts. The following table summarises the position:

- 2.8 In light of the downturn in economic activity and the particular impact that this has had on new buildings in Milton Keynes, consideration has been given as to the certainty of the new build figures. In particular, all new developments have been scrutinised to see how far they have progressed in 2009/10 and the likelihood that new buildings will be completed in the remainder of this year and 2010/11. The figures have accordingly been scaled back to what is considered the most likely outcome.
- 2.9 This is in line with the methodology adopted last year and the current projected outturn on the collection fund is a small surplus.
- 2.10 The one change that is recommended this year is that the adjustment for non-collection of Council Tax should be reduced in line with the collection rates achieved to date during 2009/10. This would imply a collection rate of 98.85%, which is an improvement of 0.15% on the figure used in calculation of the taxbase in previous years.
