## **Annex 1 - Mandatory conditions**

- 1.1 No supply of alcohol may be made where there is no designated premises supervisor in respect of the licence, or when the designated premises supervisor does not hold a personal licence or it is suspended.
- 1.2 Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

## **Annex 2 - Conditions consistent with the Operating Schedule**

*INFORMATIVE: Conditions that solely apply to fire safety are disapplied if they are applicable to article 43 of the Fire Safety Order (i.e. they are covered under the requirement to carry out and implement adequate fire risk assessments).*

- 2.1 Licensable activities are restricted to the internal ground floor area marked on the attached plan(s) apart from Late Night Refreshment and alcohol supply which are also permitted to the patio area shown
- 2.2 The supply of late night refreshment is restricted to consumption in the premises or on the patio area shown (i.e. no takeaway sales after 23:00)
- 2.3 An adequate CCTV system will be maintained in working order
- 2.4 In respect of the hours given above for alcohol sales the above restrictions do not prohibit:
  - 2.4.1 during the first twenty minutes after the licensed hours, the taking of the alcohol from the premises unless the alcohol is supplied or taken in an open vessel;
  - 2.4.2 consumption of the alcohol on the premises or the taking of sale or supply of alcohol to any person residing in the licensed premises;
  - 2.4.3 the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;
  - 2.4.4 the sale of alcohol to a trader or club for the purposes of the trade or club;
  - 2.4.5 the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces;
  - 2.4.6 the taking of alcohol from the premises by a person residing there; or
  - 2.4.7 the supply of alcohol for consumption on the premises to any private friends of a person residing there who are bona fide entertained by him at his own expense, or the consumption of alcohol by persons so supplied; or
  - 2.4.8 the supply of alcohol for consumption on the premises to persons employed here for the purposes of the business carried on by the holder of the licence, or the consumption of liquor so supplied, if the liquor is supplied at the expense of their employer or of the person carrying on or in charge of the business on the premises.

- 2.5 Off Sales of alcohol for consumption beyond the premise boundary must be sold in a sealed container and must not be consumed within the premise boundary.
- 2.6 All external windows and doors to the ground floor area shall be maintained closed during regulated entertainment except for ingress, egress and emergency
- 2.7 There will be no under 18s on the premise during adult entertainment (e.g. exotic dance nights)
- 2.8 Persons under 16 must be accompanied by an adult whilst on the premise and other than for access and egress will not be permitted in the bar area as shown on the attached plan.
- 2.9 There shall be no adult entertainment or services, activities, other entertainment or matters ancillary to the use of the premises that may give rise to concern in respect of children.

### **Annex 3 - Conditions attached after a hearing by the licensing authority**

- 3.1 The Premises Licence Holder will maintain membership of any existing Barwatch Scheme of which the premises licensed is a current member, or join any future scheme which is not currently in existence. He/she will ensure co-operation with the relevant scheme, abide by any rules and ensure meetings are regularly attended.
