

Scheme of Delegation for the Regulatory Committee

Introduction

1. There are a number of functions delegated to the Regulatory Committee by the Full Council. These functions are listed at Appendix A to this document.
2. The Committee may then lawfully delegate these functions to a sub committee or to an officer of the authority.
3. Officers may further delegate any of the functions delegated to them.
4. This scheme of delegation for the Regulatory Committee does not form part of the Council's constitution. However it is recognised that where there appears to be any doubt, the Articles and Procedure Rules within the Constitution will take precedence.

Delegations

5. This is a scheme of delegation by exception.

Delegations to Officers

6. All functions listed at Annex A are delegated to the head of service with management responsibility for the functions unless specifically reserved to the Regulatory Committee or a sub committee thereof.
7. Any delegation to the head of service with management responsibility for the listed functions may be exercised on his/her behalf by any other officer authorised in writing by her/him, either generally or specifically.

Matters reserved to the Committee

8. The Regulatory Committee reserves to itself;
 - The adoption of all policy documents developed within the scope of the functions set out at annex A.
 - Adoption of conditions applicable to drivers; vehicles or operators of Hackney Carriages or Private Hire Vehicles
 - Setting hackney carriage fares
 - Limitation of Hackney Carriage vehicle numbers

Matter reserved to the Sub Committee of the Regulatory Committee

9. Any matters referred by officers in respect of contested applications for;
 - Hackney Carriage; private hire and operator licences
 - Sex establishment licence applications
 - Street Trading Consents

And any other officer referred matters seen as appropriate from time to time

Urgent decisions

10. Any matter covered by this scheme of delegation, whether or not reserved to the Regulatory Committee or a sub committee thereof may be taken by the Chief Executive on the basis of urgency. Where it has been necessary for the Chief Executive to take a reserved decision he will report the reasons for urgency back to the next full meeting of the Regulatory Committee, or where no such meeting exists, back to the Council.
