INCIDENTS REPORTED TO THE HSE

During 1999 thirty six incidents were reported to the Health and Safety Executive. These are detailed below:

1. Injured ankle whilst playing badminton with a group of students in a sports lesson. (L&D Education – Schools direct support)
2. JCB driver injured wrist when a car collided with the front bucket of the JCB. (ENV – Highways)
3. Homecarer slipped on wet floor as they went to switch on the kettle. (NS – Other NS Services – Adult Care)
4. Fell from a staircase and struck head on matwell at the bottom of the staircase. (NS)
5. Went to wash up cup and was burnt by the immediate hot water which came from the hot water tap. (L&D – Education Other)
6. Injured back when bending to pick up a towel which had fallen to the floor. (L&D – Childrens Social Services)
7. Injured back when breaking up a fight between two students. (L&D Education – Schools Direct Support)
8. Injured wrist when hand was caught in door frame. (L&D – Childrens Social Services)
9. Laceration and bites to arms after being attacked by a dog. (NS – Other NS Services – Adult Care)
10. Sudden collapse. (L&D – Childrens Social Services)
11. Lacerations to little finger after being trapped in a cutting machine. (ENV – DSO Excluding Leisure)
12. Lacerations to two fingers on left hand whilst examining a blade on a mowing machine. (ENV – DSO Excluding Leisure)
13. Strained back after putting client to bed. (NS – Other NS Services – Adult Care)
14. Puncture wound to right wrist when a rake tine went into it whilst trying to retrieve a shovel. (ENV – Infrastructure)
15. Injured ankle when foot twisted in a tractor rut in the ground whilst using a hedge trimmer. (ENV – Infrastructure)
16. Injured left foot when slipped on floor while carrying a box of documents. (L&D – Education Other)
17. Cutting grass on a ride on mower when it hit a hidden tree stump at the top of a bank causing the mower to slip about 4ft down the bank. (ENV – Infrastructure)
18. Deep laceration to the palm of left hand whilst grinding down the lip on a brake disc. (ENV – DSO Excluding Leisure)
19. Badly bruised toes after stubbing them on a bookcase. (L&D – Childrens Social Services)
20. Injured top of head after walking towards toolbox in a car pit and hit top of head on pit boarding. (ENV – DSO Excluding Leisure)
21. Injured back whilst shaking out a duvet cover at a client's house. (NS Other NS Services – Adult Care)
22. Travelling in a car and another car collided head on. Bruised foot and ankle. (NS Other NS Services – Adult Care)
23. Electric shock to left hand. (L&D – Education Other)
24. Burn to right hand when adjusting shute on woodchipper - reached out and caught exhaust pipe. (ENV – Infrastructure)
25. Injured head and body when hit by a caravan which was being towed. (ENV)
26. Injured back whilst lifting client onto bed. (NS Other NS Services – Adult Care)
27. Concussion after banging head on fire extinguisher. (L&D Education – Schools Direct Support)
28. Injury to back and leg whilst trying to restrain a struggling child. (L&D Education – Schools Direct Support)
29. Strain to back. (NS Other NS Services – Adult Care, Homecare)
30. Dislocated shoulder whilst attempting to climb a locked gate having been accidentally locked in. (ENV – DSO Excluding Leisure)
31. Strained back after lifting a heavy object. (ENV, Regulatory Services, Environmental Health)
32. Sprain to knee – injury was a result of another vehicle pulling out in front of the vehicle being travelled in. (NS, Other NS Services – Adult care)
33. Fracture to left humerus after slipping and falling over while walking. (L&D Education – Schools Direct Support)

34. Lacerations to back of head after tripping on a stool and falling backwards towards the floor. (L&D Education - Schools Direct Support)
35. Fracture to arm after tripping over an object on the floor. (L&D Education - Schools Direct Support)
36. Dislocation of the shoulder whilst helping to dress a client. (NS Other NS Services – Adult Care)
