## Annex 1 - Mandatory conditions

No supply of alcohol may be made where there is no designated premises supervisor in respect of the licence, or when the designated premises supervisor does not hold a personal licence or it is suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence

# Annex 2 - Conditions consistent with the Operating Schedule

Licensable activities are restricted to the internal bars and restaurant marked on the attached plan

Relevant staff will receive ongoing training on licensing matters including compliance with licence conditions and the provisions of the Licensing Act 2003.

The Premises Licence Holders will maintain membership of any existing Barwatch Scheme of which the premises licensed is a current member, or join any future scheme which is not currently in existence. He/she will ensure co-operation with the relevant scheme, abide by any rules and ensure meetings are regularly attended.

#### ALCOHOL

In respect of the hours given for alcohol sales the above restrictions do not prohibit: a. during the first twenty minutes after the licensed hours, the taking of the alcohol from the premises unless the alcohol is supplied or taken in an open vessel;

b. consumption of the alcohol on the premises or the taking of sale or supply of alcohol to any person residing in the licensed premises;

c. the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;

d. the sale of alcohol to a trader or club for the purposes of the trade or club;

e. the sale or supply of alcohol to any canteen or mess, being a canteen in which he sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces;

f. the taking of alcohol from the premises by a person residing there; or the supply of alcohol for consumption on the premises to any private friends of a person residing there who are bona fide entertained by him at his own expense, or the consumption of alcohol by persons so supplied; or

g. the supply of alcohol for consumption on the premises to persons employed there for the purposes of the business carried on by the holder of the licence, or the consumption of liquor so supplied, if the liquor is supplied at the expense of their employer or of the person carrying on or in charge of the business on the premises. h. Off Sales of alcohol for consumption beyond the premise boundary must be sold

in a sealed container and must not be consumed within the premise boundary

#### LATE NIGHT REFRESHMENT

Supply of late night refreshment is restricted to consumption on the premise (i.e. no takeaway sales after 2300hrs)

#### LIVE MUSIC

A maximum of two performers during any opening period

#### CHILDREN

Except for access, egress and emergencies children are not permitted in the bar areas shown on the attached plan

#### Annex 3 - Conditions attached after a hearing by the licensing authority

Except for ingress, egress and emergency all external doors and windows must be kept closed after 23:00hr until premise closure

Except for egress and access use of outside areas by patrons shall cease no later than 2300hrs each night

Notices shall be prominently displayed at customer exit points requesting that patrons leave the premises quietly.
