Statutory responsibility to deliver an annual assessment

2. **Background**

- 2.1 SaferMK Partnership is responsible for completing an annual Strategic Assessment and implement a Community Safety Strategy for Milton Keynes.

- 2.2 The Home Office guidance suggests that the Strategic Assessment must include:
- Analysis of the level and patterns of crime, disorder, substance misuse and reoffending;
 - Changes in the levels and patterns of crime, disorder, substance misuse and reoffending
 - Analysis of why these changes have occurred; and
 - Assessment of the extent to which last year's plan has been implemented.
- 2.3 The Strategic Assessment should include input from all partner agencies who should contribute data and commentary to go towards the document.
- 2.4 It is proposed that the Strategic Assessment will need to be drafted by 26 May 2017 and circulated, by email, to SaferMK Partners for comments. The document will then be finalised and an Executive Summary will be submitted for approval at the Partnership meeting in June and published thereafter.
- 2.5 The findings from the Strategic Assessment will be used to inform a new Strategy for 2018/2020, which will be presented to the SaferMK Partnership at the autumn 2017 meeting.
- 2.6 The deadline for information to be included in the Assessment should be with the SaferMK Support Team by Friday 28 April 2017.
- 2.7 It is proposed that the Strategic Assessment analyses data from 1 January 2016 to 31 December 2016 giving a full 12 month period for analysis and leaving no gaps in analysis from previous documents.
- 2.8 Proposed Sections within the Strategic Assessment
- Data analysis and descriptions on specific projects and initiatives on each strategic outcome for the previous 12 months including:
 - All Crimes and ASB;
 - Arson and Deliberate Fires;
 - Road Safety and Reducing Road Traffic Fatalities;
 - Violence offences
 - Violence Against Women and Girls and other Gender Based Abuse;
 - Hate Crime;
 - Cohesion between Communities, Community Engagement and Reducing the Fear of Crime;
 - Cybercrime

- Reducing the effect on crime and harm caused by drugs and alcohol;
- Reducing Reoffending. including young people
- Impact by Organised Crime Groups
- Protecting Vulnerable Residents and Adults at Risk
- Emerging risks and priorities identified as a result of acquired intelligence and from the data analysis
- A summary of priorities from each partner will be included.

3. Recommendations

- 3.1 That the requests for data from the SaferMK Support Team be prioritised for analysis and commentary, and to ensure that the data sets and analysis are completed as draft to allow the document to be developed.
- 3.2 That the Partnership agree to the proposal above; and its timelines and to make any further recommendations on sections, emerging priorities and any other analysis on data sets.
- 3.3 That for each contributing agency/service to request to provide a written review of their current strategic outcomes/priorities alongside the data, be provided to the Head of Community Safety by 28 April 2017.

4. Comments/Recommendations from the Overview and Scrutiny Management Group

- 4.1 There are no specific comments in relation this report. However, it is a statutory obligation for the Committee to hold the activities and performance of the Partnership to account.

5. Implications to SaferMK Partnership
