2	<p>Business items</p> <p>Draft notes from Integration Board (IB) 26 November 2018</p> <ul style="list-style-type: none"> • The notes of the previous meeting were agreed. <p>Matters arising and action log</p> <ul style="list-style-type: none"> • IB noted the action log and the progress made. <p>STP engagement meeting update</p> <ul style="list-style-type: none"> • IB agreed to proceed with the planned meeting on 8 January, inviting the chairs of BLMK and BOB STPs. If further conversations are needed these could take place at the next IB meeting. <p>Place Based Plan update</p> <ul style="list-style-type: none"> • AJ gave an update on the progress made against the actions in the Milton Keynes System Place Delivery Plan. • IB confirmed that the bed stocktake action should be retained. RA agreed to lead on further scoping this work beyond what had already been completed across the system and that the results of an initial mapping exercise that was already underway would be presented at a future meeting. • IB also agreed that the action around development of the MK Integrated Care Partnership should be retained. Closer working between partners illustrates that progress is being made.
